IHMM Announces Annual Certification Maintenance Fee (ACMF) Increase

Rockville, Maryland (3 November 2016) – The Institute of Hazardous Materials Management appreciates the incredible loyalty and commitment you dedicate to your hard-earned gold standard credentials in the hazardous materials management and dangerous goods transportation fields. We thank you also for your patience through our database conversion.

As we move into a new year, IHMM will be making much-needed improvements to the new database, our office equipment, and our headquarters staff as we move to better promote and manage our certification programs in the US and internationally. To support these initiatives while continuing to remain consistent with industry standards among our contemporaries, the Institute of Hazardous Materials Management (IHMM) will be increasing the annual fees for the Certified Hazardous Materials Manager (CHMM), Certified Hazardous Materials Practitioner (CHMP) and Certified Dangerous Goods Professional (CDGP) credentials, effective 1 January 2017.

IHMM sources of operational income include:

- Application fees covering application and processing costs
- Examination fees covering costs for registration, exam delivery, reporting of results, analysis of exam performance, and ongoing test development and maintenance
- Annual certification maintenance fees covering governance, staff, facility, equipment, supplies, and other operational support services and expenses, as well as promotion and expansion of IHMM programs and initiatives
- Sales of our textbook, Managing Hazardous Materials

Your annual fees are critical to the Institute's operations, and make possible the incredible growth and improvement IHMM's programs have seen in recent years. Please refer to our upcoming electronic IHMM Today newsletter for details on what we have accomplished this year.

This fee change is based on industry standards for credentials within the EH&S professions. Please refer to the chart on the next page detailing the following new changes:
