She has held various high-level positions in the field of hazardous materials and waste management, including: Regional Business Manager for Environmental Services for a national chemical company, which included directing sales management, sales accounting, operations, customer service, transportation and logistics, and compliance oversight; Corporate Account Manager with an emphasis on the oil and gas segment; and, Vice President of Sales for a recycling services provider. She also owned her own private company that specialized in compliance plan development, along with services designed to assist with building business and forming sales plans. Allison has been recognized by IHMM as a Fellow of the Institute and a Distinguished Diplomate.
